***School Parent and Family Engagement Policy
2017 - 2018
October 20, 2017***

In support of strengthening student academic achievement, The **DeKalb International Student Center (DISC)** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). - (D) Other activities are carried out, such as those described in Section 1116 of the ESSA
