We provide timely notices of Title I meetings, activities, and academic progress via the school website, Infinite Campus, and School Messenger, marquee, Parent bulletin board and flyers in primary language. These communications allow parents time to adjust their schedules for meetings and to be aware of their child's performance at school.

The school marquee is provided as an additional means of communication with our stakeholders. Curriculum Night is held at the beginning of each year where administrators and teachers provide parents information about the curriculum, academic assessments used to measure student progress and testing data. Title I Stakeholder Input meetings are provided at multiple dates and times to parents and stakeholders to respond to any suggestions or ideas they may have related to the education of their child. This information is then used to develop the school parent policy, school-parent compact, and 1% parent and family engagement set aside.

SCHOOL-PARENT COMPACT

Our school will designate a staff member to collaborate with schools in DeKalb County School District and designated agencies to support students and families. Additionally, we will provide families and students support in transitioning to their home school. We will also provide support as students' transition from 5th and 8th grades by inviting parents and students to a rising sixth and ninth grade orientation at their home school. Interpreters will be available for activities, as requested.

- Parents will be provided with materials and trainings to help their students improve mastery via DeKalb County School District Regional Parent & Family Engagement Centers, Title III Parent Outreach Classes, and DeKalb International Student Center Parent Workshops.

BUILDING CAPACITY OF SCHOOL STAFF

DeKalb International Student Center will provide training to educate the teachers, pupil services personnel, principal, and other staff in how to reach out to, communicate, and work with parents as equal partners, in the value and utility of contributions of parents and in how to implement and coordinate parent programs and build ties between parents and the school by:

Our school staff meetings will double as professional development where staff members will discuss strategies and develop ideas to enhance communication, resource sharing, and enhance relationships with community stakeholders to increase student achievement.
